NOTICE TO BUYER / ENROLLEE

- * Buyer/Enrollee **may cancel their membership at any time**, by providing our office with **written notification (not email, text or phone call)** to that effect with a **minimum of thirty (30) days** and a maximum of sixty (60) days notice. In this case, the Buyer/Enrollee will have automatic credit card or automatic C-A-F-T payments which pertain to fees due beyond thirty days cease and/or have post-dated-cheques which pertain to fees due beyond thirty days returned or destroyed, however, any and all payments already submitted for the current month and the first month following cancellation notification, or any other term, or for any other fees and/or purchases will not be refunded. (Note: tuition payments pre-paid in advance for future months or other terms will not be refunded, and they are not transferable to current or new members.)
- * Buyer/Enrollee may cancel this agreement at any time for reasons of substantial disability by providing us with a disability statement from a certified physician. In this case, upon written notification, automatic credit card or automatic C-A-F-T payments will cease during the time of disability and/or post-dated-cheques for future months during the time of disability, will be returned or destroyed. (Note: tuition payments pre-paid in advance for future months or other terms will not be refunded, and they are not transferable to current or new members, however, they may be applied to future tuition fees off for the Buyer/Enrollee following the time of disability)
- * Buyer/Enrollee understand that all fees indicated in this agreement are subject to applicable Provincial and Federal Taxes.
- * Buyer/Enrollee understand that tuition fees are due on or before the first day of the month(s) to which they apply. Post-Dated-Cheques are to be made payable on the first day of each month of this agreement. Payments received after the first day of the month will be subject to late charges. A dishonor charge will be applied to any cheques or C-A-F-T authorizations not honored and will be applied to the Buyer/Enrollee's credit card or Kopperud TaeKwon-Do Schools membership account. Cash payments must be made on or before the first day of the **previous month** to which the payment applies. (ie: December fee is due on or before November 1) Credit Card payments will be processed on or one-to-two-days prior to the first day of the month to which the payment applies. A service charge may be added to credit card tuition payments and service and/or late charges will be applied to a buyer/enrollee whose credit card is not honored.
- * Due to the continuing nature of Physical Fitness and Martial Arts training, **this agreement will continue indefinitely and uninterrupted**, and will remain in effect as tuition or course payments are received regardless of any changes in program/school schedule, procedures or fees.
- * Buyer/Enrollee understands that he/she should take promotional rank examinations scheduled or upon the recommendation of their instructor.
- * Buyer/Enrollee understands that uniforms, seminars, examinations, tournaments, provincial/national/international association fees, etc., are separate from tuition fees. Buyer/Enrollee understand that tuition and other fees may change at any time with thirty (30) days notice.
- * New members are subject to a new-member-fee and renewing members are subject to a annual-renewal-fee. This renewal fee may be required following any interruption of membership and/or monthly training except in the case of verified substantial disability.
- * Days, times and locations of classes are subject to reasonable change without notice. Classes may or may not be conducted on national, provincial or civic holidays, or on days in which a rented facility is made unavailable by the owner/landlord.
- * Unified TaeKwon-Do International, Kopperud TaeKwon-Do Schools Inc, and/or affiliated schools/clubs may, at any time, terminate this agreement/membership. In this case, all fees received in advance, for future tuition charges only, beyond the current month, will be refunded and/or automatic credit card or automatic C-A-F-T payments will cease and/or post-dated-cheques will be returned or destroyed, however, payments already received for the current month or term, or other fees/purchases will not be refunded and are not transferable.
- * Buyer/Enrollee represents that he/she is in good health and suffers from no physical, mental or social impairment which would restrict his/her participation in the classes, examinations and other activities or jeopardize his/her, or another persons health in any way from doing so. Buyer/Enrollee realizes that there is a risk of injury involved in participating in TaeKwon-Do classes, examinations and other activities and voluntarily assumes the risk of accident, injury, damage, loss or other harm of any kind to his/her person or property as a result of participating in Unified TaeKwon-Do International, Kopperud TaeKwon-Do Schools Inc. and/or affiliated schools/clubs classes, examinations, tournaments and/or other activities or which may occur as a result of intentional or negligent acts caused by third persons. Buyer/Enrollee agrees to hold Unified TaeKwon-Do International, Kopperud TaeKwon-Do Schools Inc., affiliated schools/clubs, officers, agents, employees, instructors, fellow members and authorized guests harmless from any/all claims, liability, demands, suits, actions or other proceedings of any kind.
